

## **Athletic Field Rental Conditions**

### **Definitions:**

- \*Athletic Reservation Form: document that provides all information needed to make a formal request to reserve a field
- \*First Right of Refusal: Associations that have had reservations on a field the previous season will have the first right to reserve the field that same season next year
- \*In Good Standing: all facility fees have been paid in full, the athletic field reservation contract and addendum has been signed and Park and Recreation requirements are met
- \*Subleasing: a lease granted by one who is already a lessee of a property

### **Field Availability:**

- \*The Park District Manager will determine the athletic field facilities are available for rent.
- \*Fields take out of service for field renovation or resting will not be permitted for use.
- \*Fields are designated for one sport only. The department does not have multi-use fields.
- \*Reservations will be accepted per season. The dates of the season are determined by the individual sport.
- \*Fields reserved by a league the previous season year will have the first rights of refusal to the field the next season year.

### **Permit Process:**

- \*Athletic League representatives will complete an Athletic Field Reservation form, listing the fields, dates, and times requested
- \*The Athletic Field Reservation form may be submitted to the Athletic and Reservations Office up to three months in advance of the requested dates. Requests must be received no later than 14 days in advance of the requested dates.
- \*Athletic Field Reservation request forms received after the deadline are subject to denial and loss of the first right of refusal.

## Athletic Field Rental Conditions (cont)

### General Considerations:

### Payments:

\*League reservations made up to 90 days in advance of the request dates must be paid in full 30 days prior to usage. Request received 30 to 14 days prior to the start date must be paid in full at the time the request is submitted and approved.

\*All leagues and associations must sign that they acknowledge and will adhere to the Dallas Park and Recreation Athletic Field Use Rules final approval of the use of fields.

### Penalties for Infractions:

#### **Alcohol consumption and disorderly conduct is prohibited.**

\*First reported infraction: the athletic league will be required to have a police officer, arranged through the Reservation Office, at the expense of the league, for a minimum of one month after the occurrence of the offense.

\*Second reported infraction: the athletic league will be required to have one or more police officers, arranged through the Reservations office, at the expense of the league, for a minimum of four months.

\*Third reported infraction: League will be suspended from reserving the field for one year and will lose first right of refusal privileges.

#### **Play is prohibited on athletic fields closed for renovations or declared unsafe for play. The penalty violation is:**

\*First infraction: 60 days suspension

\*Second infraction: 6 months suspension and loss of first right of refusal

\*Third infraction: 1 year suspension

\*Fourth infraction: permanent loss of the field

#### **Subleasing of fields is prohibited:**

\*First infraction: 60 day suspension

**Athletic Field Rental Conditions (cont)**

\*Second infraction: 6 months suspension and loss of first right of refusal

\*Third infraction: 1 year suspension and loss of first right of refusal

\*Fourth infraction: permanent field loss

**Play is prohibited when fields are wet.**

\*Payment to repair the field and reimbursement to the City of Dallas Park and Recreation Department for lost revenues due to the field closure.

\*At the discretion of the Park and Recreation Department, field reservations may be cancelled for up to 60 days.

**Sports play is not permitted on park areas not designated or approved for organized sports play.**

\*First infraction: a warning will be issued

\*Second infraction: ticketed with a trespass violation

Parking is permitted in designated parking areas only. Violators will be ticketed or towed.

Merchandise, concession sales, and charging admission to athletic events are not allowed unless approved by the Dallas Park and Recreation Department Staff.

**Users must vacate athletic fields when the reservation period ends. The penalty for violation of this rule is:**

\*First infraction: 60 days suspension

\*Second infraction: 6 month suspension and loss of first right of refusal

\*Third infraction: 1 year suspension

\*Fourth infraction: permanent loss of the field

**Users are responsible for picking up and disposing of litter. The permit holder is responsible for the cost of excessive cleanup. Leagues will pay a deposit in the amount determined by**

**the City, to pay for excessive litter, damage, or loss of property. The penalty for excessive litter is:**

\*Funds will be drawn from the deposit for cleanup, damage or loss of property

\*The original amount of the deposit must be replaced before athletic field reservations are resumed.

\*Repeated infractions of this rule (3 or more) may result in the user being required to place litter pick up and disposal on contract.

**Refunds/Credit**

In case of rainouts, leagues will be required to contact the Reservation Office Staff within five business days after scheduled play, in order to get a credit or refund.

Cancellations for field reservations must be made 24 hrs in advance of reservation date in order to receive credit.
